1. BACKGROUND INFORMATION

1.1 Beneficiary Country: Albania

1.2 Contractor: UET, Tirana

1.3 Short description of the project:

The project **Design Measure Digital Entrepreneurship – DMDE** is funded by the ERASMUS + "KA2–Erasmus Mundus". It is going to be implemented in Albania, Austria and Cyprus from October 1, 2023 up to December 31, 2024.

DMDE tries to establish the ground for a Joint master's degree that will address the priority of a Europe fit for the Digital age, by empowering people through digital education, skills and competences. The overall aim of DMDE is to design an Erasmus Mundus Joint master's degree which fills the gap in teaching/training skills, knowledge and competencies related to (digital) entrepreneurship. The joint diploma will enable graduates to better understand economy trends and challenges to respond to nowadays societal needs.

The design measure will lead the Master Program on 'Digital Entrepreneurship' into two main objectives:

- To enable students to become entrepreneurs using digital business models.
- To educate students to become intrapreneurs who contribute to the digital transformation in
- established companies.

The specific objectives of DMDE are:

- To analyse the needs of students to be improved through education and training.
- To analyse the current state of knowledge and skills of each HEI in digital entrepreneurship.
- To design modules and corresponding ECTS for DMDE.
- To define all teaching/training courses to be developed during the DMDE.
- To identify all non-academic activities related to the MMDE.
- To coordinate DMDE from the management and administrative point of view.
- To define admission criteria and the application procedures for students to be enrolled in MMDE.
- To actively and continuously promote DMDE.
- To define the following evaluation process of MMDE.
- To conclude with a Final DMDE Design and to apply for EMJM.





2. DESCRIPTION OF THE ASSIGNMENT

2.1 Objectives

Specific objective

The Contractor will design and develop the project website dedicated to the project activities.

Criteria for legal persons:

- 1- the tenderer has provided services under at least one contract which [were] implemented at any moment during the following period the past three years.
- 2- Previous work experience with EC funded projects in Erasmus + will be an asset

Criteria for natural persons:

- 1- the tenderer has worked successfully on at least one project in fields related to this contract in the past three years.
- 2- Previous work experience with EC funded projects in Erasmus + will be an asset
